Parent Refusal to Complete the FAFSA Documentation Form

Federal Regulation under the Higher Education Opportunity Act, Section 472 (HEA section 479 (a)) gives a dependent student the right to borrow a Federal Unsubsidized Loan when the student's parents have ended financial support and refuse to file the Free Application for Federal Student Aid (FAFSA).

Important Note: This form does not allow a student to apply for financial aid as an independent student. Students must understand that they are requesting only an unsubsidized loan subject to the limits for dependent students. **A Federal Direct Unsubsidized Loan is not based on financial need and is a loan that must be repaid. No other federal, state, or institutional need-based aid will be available.**
