

TEXAS PUBLIC EDUCATION GRANT-DUAL CREDIT ACADEMIC YEAR 2018 - 2019

The Texas Public Education Grant (TPEG) may be awarded to cover fees for courses taken through the Dual Credit Program. Students must be accepted into the Dual Credit Program prior to applying for financial assistance. Awards will be based on financial need and the availability of funds.

Application Process

All applicants must submit:

1. **Electronically submit the Free Application for Federal Student Aid (FAFSA).** Use [The FAFSA Website](#) to submit your 2018-2019 Federal Student Aid Application.
2. A copy of parent's **2016 IRS tax return transcript(s)**. To obtain an IRS tax return transcript, go [The IRS Website](#) and click on "Get Your Tax Record" then click on "Get Transcript by Mail" and follow instructions. You may also utilize the IRS Data Retrieval Tool when completing the FAFSA (which is recommended).
3. Attach proof of any **untaxed income**.
4. Attach completed **2018 - 2019 Status 1 Dependent form**. Go to the [Del Mar College Website](#), click on "New Students," then click on Afford, "then click on Forms/Documents. Click on view all forms, and then click on 2018 – 2019 Forms. The form is available for printing.
5. Submit completed application packet to **Financial Aid Services, Del Mar College, 101 Baldwin Blvd., Corpus Christi, TX 78404-3897.**

It is recommended that this packet be submitted with all required documentation, which includes this application, to meet our priority deadline of July 1, 2018. Incomplete application packets will not be considered, due to limited funds. You will be notified of the results of your application.

Please remember that the Del Mar College Dual Credit Grant will cover **only** fees. **Funds are limited.**
