TRAINING FEE

In-region training fee applies to students who are commissioned by a local law enforcement agency. This refers to agencies within the 11 counties being serviced the Coastal Bend Council of Governments (CBCOG) namely: Aransas, Bee, Brooks, Duval, Jim Wells, Kleberg, Kenedy, Live Oak, Nueces, Refugio, and San Patricio.

Out-of-region training fee applies to students who are commissioned by law enforcement agency outside of the CBCOG region. Same applies to personnel of a state and/or federal agency, individuals not commissioned by any law enforcement agency at the time of registration, and those employed by third party service providers in contract with a local law enforcement agency.

*APPLICATION REQUIREMENTS & TESTING FEE

To register for this course, student should first apply and qualify. Check the website or call (361) 698-2644 for details. Those who successfully complete the course will take the State Exam. Payment of \$25.00 testing fee will be required in order to take the State Exam.

ADDITIONAL COURSE INFORMATION

(#1014) Basic Instructor Certification A trainee should have either two year experience as a peace officer, telecommunicator, or jailer, OR bachelor's degree and two years of teaching experience, OR a graduate degree.

(#1849) De-escalation Techniques Intended for Peace Officers working toward their intermediate, and advanced proficiency certificate on or after April 1, 2018.

(#1850) Crisis Intervention Training 40HR Peace Officers working toward their intermediate proficiency certificate on or after April 1, 2018, and within 2 years of licensing date for those licensed on or after April 1, 2018.

(#2222) Firearms Instructor Certification_ Trainee should have at least three years' experience either as a law enforcement officer or as a firearms instructor. Currently holds an Instructor License issued by TCOLE.

(#3599) County Corrections Firearms Course A trainee should currently hold a Jailers License, and is not prohibited by state or federal law or rule from attending trainings related to firearms or from possessing a firearm.

(#3702) Field Training Officer / CTO Trainee should at least be a recipient of Basic Proficiency Certification.

(#3737) New Supervisor Trainee is assigned to his/her first supervisory role. Per HB 3211, "A Peace Officer who is appointed or will be appointed to the officer's first supervisory position must receive in-service training on supervision no earlier than the 12th month before or later than the appointment date", as the case may be.

(#4900) Mental Health for Jailers Course is intended for a person in the position of county jailer on September 1, 2017. This course must be completed no later than August 31, 2021. Pre-requisite for Jailers TCOLE licensing.
