## Freedom to Dream Waiver Program – What is the same?

### Who qualifies?

- Graduating High School Seniors
- Adult Learners / GED
- Students living in the taxing district
- Maintain a minimum 2.0 cumulative GPA
- Must be enrolled in 12 semester credit hours
- Students commit to a formal agreement or "contract"

### Freedom to Dream Waiver Program – What is new?

### Who qualifies?


- Class of 2026 Dual Credit seniors eligible with a minimum 2.0 GPA
- Students with previous college credits
  - 12 semester credit hours or less with a minimum 2.0 GPA
  - No more than 18 attempted credit hours
- Students enrolling in a Continuing Education Program
  - Continuing Education Program, must be enrolled in all required course(s) needed to earn an Institutional Credential leading to a Licensure (ICLC) or Workforce Skills Award (WSA)


## **College Ready vs Readiness**

- 1st Cohort Freedom to Dream 2025
  - Approximately 725 students were college-ready (R3 E3 M3).
  - Approximately 180 students were college-ready for OSA/Cert 1 programs.
  - Approximately 975 students were not TSI complete, students needing to take developmental coursework in Reading, English, and/or Math.
- 2<sup>nd</sup> 2.0 Cohort Freedom to Dream 2026
  - Must be college-ready to start the program (major).
  - We want to serve all students. If you're not college-ready, we have other options.
  - College Preparatory Pathways.
  - Continuing Education Programs.
    - Institutional Credential Leading to Licensure or Certification (ICLC) / Workforce Skills Awards (WSA).
  - Dual Enrollment Pipeline.








## Freedom to Dream Enhancements for Next Cohort

- Success coaching and peer mentoring in development.
- Contract requiring students to seek help before dropping.
- Program will cover up to 60 semester credit hours, not 3 years.






## Freedom to Dream Enhancements for Next Cohort

- Students must be college-ready for their program of interest or pursue continuing education options.
  - Texas Success Initiative Exam
    - Reading, English, and Math
- New college prep pathway being created for those who are not ready.


### **Continuing Education Annual Headcount**


