

# 2014 Capital Improvement Program Fact Sheet Expenditures Proposal

If approved by voters in November 2014, some new construction projects should be available for use in 2018.

#### **EAST CAMPUS**

#### General Academic Complex /Phase II Music

\$45,393,000

New space for General Academic and Music education will provide technologically-enhanced classrooms for English, mathematics, social and behavioral sciences, developmental education and GED instruction, and replace inadequate music practice rooms and faculty offices.

#### **Major Renovations of Existing Buildings**

\$9,121,819

Structural limitations of the original Music Building no longer serve the needs of today's fine arts students. Renovations to repurpose other existing spaces will be extensive.

- · Repurpose Heldenfels Admin. Bldg. into Student Enrollment Center
- Information Technology upgrades

## **Partial Renovation of Existing Buildings**

\$12,790,800

Renovations will upgrade major building systems in the William F. White, Jr. Library including mechanical, electrical and plumbing systems. Renovations will upgrade facilities to current ADA requirements and enhance student-learning environments.

- Harvin Student Center Expand Student Leadership and Campus Life functions
- White Library Increase Learning Laboratory functions
- Bring all facilities to current ADA standards

## **Demolition of English Building**

\$255,780

New teaching methodologies require more flexible classroom space with more technology capabilities.
